Item, I give and bequeath unto my son Edmund Grantham all that my one yardland of arable meadow and pasture with appurtenances lying in the .... of Southnewington afs. with all manner of commons thereunto belonging, which I lately bought and purchased of one Humphrey Coates of Binfield in the co. of Northampton afs. with the said one yardland ....

Item, I give and bequeath unto my ... daughter Mary Grantham the sum of one hundred and fifty pounds of good current lawful money of England to be paid to her at the age of six and twenty years which shall be paid to her one month after... by my executrix hereafter mentioned.

Item, I give and bequeath unto my ... daughter Frances Grantham the sum of one hundred and fifty pounds of good current lawful money of England to be paid to her at the age of six and twenty years ....by my executrix hereafter mentioned. Item, I give and bequeath unto my godson Thomas, son of my loved brother Joseph Grantham the sum of ten shillings lawful English money to buy him a sheep. Item, I give and bequeath unto my godson Thomas, son of my loved brother Richard Grantham the sum of ten shillings lawful English money to buy him a sheep. Item, I give and bequeath unto my kinsman Thomas, son of my kinsman Thomas Grantham of Ardley in the co. of Oxon afs the sum of ten shillings lawful English money.

Item I give and bequeath unto my kinsman Thomas Easeman ten shillings of lawful English money.

Item, I give and bequeath all the rest and residue of my personal estate goods chattels ready money or debts herebefore unbequeathed whatsoever in any wise belongeth or appertaining making and appointing Ann my said wife full whole and sole executrix of this my last will and testament. .... Order and appoint my loved kinsman John Stephens to be overseer of this my last will and testament giving to the said John Stephens five pounds of good current lawful money of England to be paid by my executrix aforementioned. And I do hereby revoke and annul all former wills by me ... heretofore made. In witness whereof I the said Thomas Grantham have hereto set my hand and seal the day and year first above written.
